



## HOLY FAMILY SHOOOL SCRIP AGREEMENT FORM 2019-2020

Holy Family School (referred to herein as “we,” “us” and “our”) sponsors a scrip program which allows you to purchase scrip. The scrip you purchase through our program generates rebates from the participating retailers. These rebates can be used as a credit to your tuition account, cash back to you, and/or a gift to the school. The parties agree as follows:

1. Rebates earned will be used in the following ways:

a. **50 % will be retained for running the scrip program (NOT deductible)**

Our scrip program distributes the rebates one time per year in the month of June. Families that choose to use SCRIP rebates toward their tuition will receive the 2018-2019 rebates for the 2019-2020 school year.

With respect to your charitable contributions, we will provide you with all required acknowledgements under sections 170(f)(8) and 170(f)(17) of the Internal Revenue Code.

### Terms and Conditions of PrestoPay and check orders:

1. You agree to use sufficient funds directly in your bank account for all PrestoPay and check purchases.
2. Should there be insufficient funds and your order is canceled, you will be responsible for the \$30 fee overdraft fee, payable to Holy Family School before you place your next order via PrestoPay or by check.
3. Should there be insufficient funds and your order has already been placed, you will be responsible for the total amount of the gift certificate purchase, plus the \$30 overdraft fee, payable to Holy Family School before your next gift card order is placed via PrestoPay or by check.
4. You agree that the first time an order is placed by PrestoPay or by check with insufficient funds, your PrestoPay account will be “locked” and we will not accept check or PrestoPay orders until payment has been received in full to Holy Family School.
5. If any overdraft fees have not been paid in full it will be added to your FACTS Management Tuition account.
6. Purchaser is aware that a \$.15 charge will be added to their total purchase each time they use PrestoPay. (ex. Purchase \$100 in gift cards your account will be charged \$100.15)

You agree to indemnify us against any loss incurred in connection with there being insufficient funds in your account to cover the checks or ACH transfers you issue to pay for your scrip. We make no representations or warranties of any kind with respect to the scrip. This agreement continues unless replaced by another, and can be terminated by either of us upon 60 day’s advance notice to the other.
